2015-16 Youth Initiatives

S. Lazare announced a potential collaboration with the New Jerey Chamber of Commerce Foundation (NJCCF) to do a youth mentorship program and fundraising to supplement WIB youth initiatives. S. Lazare introduced Dana Egreczky and Patty Cullinane from the New Jersey Chamber of Commerce Foundation. D. Egreczky presented to the

Board the various programs offered by NJCCF and distributed supporting materials. D. Egreczky went into details about its model mentorship program and expressed an interest in bringing the program to Bergen County. D. Egreczky then answered questions from the Board. C. Polack announced that S. Rosario is now Vice Chair of the Youth Investment Council. S. Lazare announced that she will be presenting to the State Employment and Training Commission (SETC) in February to advocate for future funding to continue the Youth Symposiums.

Governance Committee

M. Devaney reported that the Committee held its first meeting and drafted its Charter. There will be an upcoming election for Secretary and Treasurer of the Board. The Committee is seeking additional members. Anyone interested should email C. Polack.

Treasurers Report

G. Charne reported on the One-Stop budget (as of 11/30/2014) included in the Board Packet. The Performance Outcome Report (dated 1/6/2015) was reviewed. It was explained that the drop in in Adult Retention is due, largely in part, to the shelter program participants not retaining the jobs they were placed in. It was also explained that the drop in the youth numbers is due, in part, to a database cleanup. G. Janz answered a question from the Board about the WorkFirst New Jersey Recession (Res. No. 2015-02) by explaining how the WFNJ program and funding stream requirements, and how it differs from other funding streams.

One-Stop Director Report

G. Janz reported to the Board on the implemented customer flow changes. It was announced that the youth funding allocations, as per the new legislation (WIOA), is 25% in-school youth and 75% out-of-school youth. It was announced that the Bergen One-Stop will be hosting an orientation on January 21st to reach out to more out-of-school youth and get to get them into the program. It was announced that Donna Todd will serve as the single-point-of-contact for businesses coming directly through the WIB and One-Stop (outside the Business Resource Center).

Site Reviews

C. Polack announced the call for volunteers to participate in the upcoming WFNJ site reviews. S. Lazare and M. Devaney shared their site review experiences and the importance for Board participation in them.

Committee Reports

Committee reports were distributed in the Board Packet. No questions were received from the Board. L. Weiss reported that the Business Development Committee is planning to host a Business Expo in the Spring in partnership with Chambers of Commerce and that an Older Workers subcommittee was formed. C. Polack read the Executive Director report on behalf of T. Molinelli.

> Old Business

S. Blumenthal updated the Board on the board insurance coverage. The insurance provider clarified that members companies are covered under the plan as well. S. Blumenthal read the suggested language for the reserved Section IX of the WIB Bylaws. A motion was made by A. DeGiulio, seconded by P. Goldfarb, to amend the Bylaws with the recommended language. Discussion followed. Motion failed. A motion made my J. Thebery, seconded by J. Linter, to table the bylaws amendment unanimously passed. The Board asked that the language be modified to be less restrictive since the bylaws are secondary to the insurance policy.

S. Blumenthal opened discussion on the board meeting frequency, time, and location. Discussion followed. Motion made by T. Eastwick to move the meeting location to Bergen Community College. G. Charne seconded the motion. Roll call vote for motion was taken, all in favor: 16, all opposed: 9. Motion passed.
